2018 Artistic Regional to be held in Appleton, Wisconsin:

The rink owner has been working hard getting everything ready. They added the necessary figure and loop circles. The operator plans to have a face book page posting both regional and local information.

John Cawly requested time for a presentation for dance and free style coaches to be presented during the regional contest explaining the new scoring. After discussion it was decided that we cannot plan for this at this time. We must be able to complete the contest on time without adding time to the contest or more expenses to skaters or the board by

extending the contest. After all entries are in and a schedule is prepared if time permits a presentation can then be scheduled.

Bids for 2019 Speed Regional contest: Two bids were presented; Extreme Wheels in Crystal Lake, IL and Skate Express in Watertown WI. Marty Laufer made the motion that Extreme Wheels be the 2019 host site and Skate Express the alternate site. Bob Babcock seconded the motion and it was carried unanimously. Extreme Wheels in Crystal Lake, IL is the host rink for the 2019 GL speed regional contest.

Bids for 2019 Artistic Regional contest: Two bids were presented; Skatetown USA in West Chester, OH and Youngstown Skate Center in Youngstown, OH. Bob Babcock made the motion that Youngstown Skate Center in Youngstown, OH be the host site for the 2019 GL Regional contest. Marty Laufer seconded the motion and it was carried unanimously. Youngstown Skate Center in Youngstown, OH is the host rink for the 2019 GL artistic regional contest.

Confirmed judges for 2019 : Leslie Dunn-Myers, Judy Graves, Lisa Holderbaugh, John Rangel, Patricia Bauler, Dennis Welsh, Scott Clifford, and John Holquist

The committee is working on inviting another judge.

John Peck made a motion to adjourn the meeting and was second by Renee Kitts and it was carried unanimously.
